

Rule book changes to be voted on at the November 12 governors' meeting include the Z07 tire choice, rally rules and hi speed licensing. A sanction change - from 7 to 10 - will also be voted on. In the past, changes could be voted on individually. For 2012, the governors will be voting "all or nothing." A "nothing" vote will keep the rulebook as is. This will also hold for the 2012 budget.

Rich has returned both Midwest and National ballots, those being for the new officers. **Paul Haack** from the Midwest Region is running for National Competition Director.

On the national level:

"NCCC Family Helping Family" program will be started. The program will help members when their vehicle breaks down away from home. Each club is asked to recruit two members to assist-one being a mechanic with trailer access and the other being able to host overnight guests in their home. Contact **Rich Luebcke** if you are interested in helping with this new program. He will provide a form for inclusion in the newsletter.

The Vision Committee is working to

understand where NCCC is growing and not growing, the composition of the Executive board, and several other initiatives.

2012 budget will be voted on in November. Money is being added for travel and meetings attended by the appointed officers. \$5,000 advance is being added to cover the next year's convention startup costs. Contact Rich if you would like a copy of the budget.




